provided that the additional individual(s) must be the close relative(s) of <u>ALL</u> the individual(s) comprised in the registrant and adequate proof of such relationship must be provided to the Vendor's satisfaction whose determination shall be final.

- (d) All the person(s) signing the Preliminary Agreement for Sale and Purchase must sign personally as purchaser. The Vendor reserves its absolute discretion to allow or reject the registrant's request to add and/or delete any individual(s).
- 9. If a registrant has not purchased any specified residential property, his/her unused cashier order will be available for collection by the registrant in person or by authorized person at 11/F, International Commerce Centre, No.1 Austin Road West, Kowloon, Hong Kong immediately after the balloting mentioned in paragraph 6 above till 8:00 p.m. on the first date of sale.
