The Purchaser (or any one of the Purchasers) or a close relative (i.e. spouse, parents, children, brothers, sisters, grandparents or grandchildren) of the Purchaser (or a close relative of any one of the Purchasers) (whether in his/her sole name or together with other individual(s)) ("related purchaser"), on or before the date of application by the Purchaser for the Grand YOHO Family Cash Rebate (which application date shall not be later than the date stipulated in paragraph (IV) below), has signed agreement(s) for sale and purchase to purchase any other residential property(ies) in the Phase ("related residential properties"); and

- (c) 買方已按買賣合約付清指定住宅物業的樓價餘額;及
 The Purchaser has settled the balance of the purchase price of the designated residential property in accordance with the agreement for sale and purchase; and
- (d) 指定住宅物業的『購買次序』(定義如下)是第二位或之後。
 The "purchase sequence" (as defined hereinafter) of the designated residential property is second or thereafter.

After the Vendor has received the application and duly verified the information, the Vendor will apply the Grand YOHO Family Cash Rebate for part payment of the balance of the purchase price of the designated residential property directly.
- (V) Grand YOHO 家族現金回贈受其他條款及細則約束。
 - The Grand YOHO Family Cash Rebate is subject to other terms and conditions.

The Purchaser can choose to instruct his/her/its own solicitors to act for him/her/it, and in such event, the Purchaser shall also bear his/her/its own solicitors' costs and disbursements relating to the First Mortgage Loan.
